OUR RESPONSIBILITIES

HOW WE MAY USE AND DISCLOSE YOUR HEALTH INFORMATION

Treatment

We may use and disclose your PHI to provide, coordinate, and manage your healthcare services.

Examples:

- Acupuncture treatment planning
- Clinical documentation
- Coordination with referring providers

Payment

We may use and disclose PHI to obtain payment for healthcare services.

Examples:

- Insurance verification
- Claims submission
- Claims review
- Payment collection

Business Associates involved may include:

- Claim.MD
- Availity

Health Care Operations

We may use PHI for:

- Quality improvement
- Compliance activities
- Staff training
- Audits
- Business management

Appointment Reminders

We may contact you regarding:

- Appointments
- Follow-up visits
- Schedule changes

Methods may include:

- Telephone
- Email
- Secure messaging
- SMS communications
- Methods may vary according to patient preferences.

Individuals Involved in Your Care

With your agreement or as otherwise permitted by law, we may disclose information to family members, caregivers, or others involved in your care or payment for your care.

As Required by Law

We may disclose PHI when required by:

- Federal law
- State law
- Court order
- Public health authorities

Public Health Activities

We may disclose PHI for:

- Disease reporting
 - Public health investigations
 - Health oversight activities
 - Reporting adverse events when required by law.

YOUR RIGHTS

You have the right to:

- Access Your Records: Inspect and obtain copies of your health records.
- Request Amendments: Request corrections to your records.
- Request Restrictions: Request limits on certain uses or disclosures.
- Confidential Communications: Request communications by alternative means or locations.
- Accounting of Disclosures: Request certain disclosure records.
- Obtain a Copy of this Notice:

You may request a paper copy of this Notice at any time, even if you have agreed to receive it electronically.

- Electronic Access:

You have the right to obtain an electronic copy of your medical records when such records are maintained electronically. We may charge a reasonable cost-based fee for providing copies.

Restriction on Health Plan Disclosures:

Request restrictions on disclosures to health plans when you have paid for services out-of-pocket in full, as permitted by law.

Personal Representatives:

Designate a personal representative to act on your behalf when permitted by law.

COMPLAINTS

If you believe your privacy rights have been violated, you may file a complaint with Tang Acupuncture or with the Secretary of the U.S. Department of Health and Human Services.
